Three Speakers

First Speaker: Jerry Christopherson, Topic: "Wreaths Across America" Jerry is President of "True Patriots Care" Jerry stated that this December the "Wreaths Across America" program will be implemented which includes placing wreaths on Veteran's graves. This year's program will include two local sites in Dundee Township (East and West Dundee). Jerry advised Board that they will be selling the wreaths between now and Xmas and placement of the 3,200 wreaths will be sometime in December. Different groups/volunteers are involved in placement. Jerry stated that at the West Dundee location, it is difficult to track down the families of those buried there and that he has asked East and West Dundee for assistance. Jerry asked the Board for financial assistance consideration to ensure that every grave gets a wreath at Xmas. Trustee Garcia asked what the cost was for a wreath, it is \$37 (\$5 off the top to non-profit groups that agree to assist with selling). In addition, there are different programs which can be viewed on the wreathsacrossamerica website. President Skillman advised he would discuss with staff and get back

Second Speaker: Cory Kelly, Topic: discuss proposal for possible space utilization at Springhill Mall (Carson Pirie Scott site).

Cory is currently working on the former "Big Lots" space in developing Athletico, Field House, Sports Food Bar, Entertainment, etc. Cory stated that he was interested in utilizing space at Springhill Mall (specifically the old Carson Pirie Scott building). Cory shared his ideas/vision that includes shipping container drops which would create a perimeter to allow food trucks to come in, in addition, setting up a screen/platform to show movies, allow people to bring in chairs, picnic tables, etc. There would be no cost to the public, the cost would be off-set by sponsorships and working with the Village. Food trucks would generate revenue for the space, live entertainment at night. Corv stated he would arrange for outside security which would coordinate with local police/fire. If approved, could have functioning within one month, would generate tax dollars and opportunities. President Skillman stated he would share proposal ideas with internal staff, more to follow.

Third Speaker: Chris Kious, Kane County Board Member District 23/Forest Preserve President. Topic: Kane County Updates

Chris advised that 12.5 million dollars (above and beyond the 17.5 million dollars already approved for this year) in the capital budget to remove the toll from the Long Meadow Parkway. Still short 5 million, negotiating with Cook and McHenry counties to generate remaining revenue needed. Thanks to legislative staff for there assistance!

Recently announced by the US Secretary of Interior recently announced that the Fox River Water Trails (working on initiative for a couple of years), has been designated as a national water trail (accepted along with 8 other water trails across the USA).
